CDM can also help you navigate the process for bringing Mexico-based witnesses to the U.S. for hearings, depositions or mediations.

CDM works with advocates to administer U.S. class and collective action settlements involving Mexico-based class members. We design claim and outreach strategies to ensure that eligible workers can participate and receive the funds to which they are entitled.

CDM's team tailors communication strategies to locate witnesses and alert migrants to their right to participate in cases in the U.S. These include in-person meetings, print, online and radio advertising, coordination with government authorities, and international earned media strategies.
