RALLYING WITH H-2A FARMWORKERS

Abigail Kerfoot, CDM's Deputy Legal Director emphasized that any expansion of programs such as H-2A should be paired with the expansion of protections for workers in stories by **The Minnesota Star Tribune** and **The Santa Fe New Mexican** about the impact of the new administration's policies.

In an investigation from **PRISM**, CDM Executive Director Rachel Micah-Jones explained how the H-2A visa program's structure leaves women especially vulnerable to wage theft and abuse.

As the threat of mass worksite raids and unprecedented deportations of immigrants continues to escalate, Jimena de Haro, CDM's Communications Director spoke to **Canal Once** about

the need for a new labor migration model centered on the human rights of workers and their families.



THE BALTIMORE BANNER

In a letter to the editor of **The Baltimore Banner**, CDM's Executive Director Rachel Micah-Jones spoke out against efforts like the Save Our Seafood Act (S.1292) to expand temporary visa programs without addressing their structural flaws.

CDM's Deputy Policy Director, Carmen Martinez, shared with **Bloomberg Businessweek** that with the expansion of guestworker programs lawmakers are scrambling to provide "solutions" geared toward making it easier and less costly for employers to hire workers but not better or safer for workers.

Elpidia, a member of our Migrant Defense Committee who works in crab picking in Maryland, shared with **Prism** how she encourages others to raise their voices against injustice.
